Oysters in the Classroom

There were many eager and hungry eyes when an aquarium of St.
Mary's River oysters was set up at Hollywood Elementary School in Ms. Molina's 4th grade class about a month ago. Many kids inquired "can we



eat them?" and it was then that we explained the St. Mary's River Watershed Association's mission. The kids learned what oysters do for the river, what animals depend on oyster reefs for habitat and food, and why restoration is necessary. The discussion included what the students can do around their home and community to help clean our Bay and live sustainably.

DNR to Discuss Stewardship of Oyster Sanctuary - December 10 5:00 p.m. at the Muldoon River Center in St. Mary's City (Free Event)

Officials from the Maryland Department of Natural Resources will hold an informal meeting to talk about how residents along the St. Mary's River can assist with protecting the oyster sanctuary. Designated a shellfish sanctuary on October 1, 2010, the St. Mary's River north of Church Point is currently off limits to the public commercial fishery. Native oysters, clams, and mussels cannot be harvested, unless...

In summer of 2013, DNR began issuing permits for aquaculture within the oyster sanctuaries. Many folks along the river were not happy with the sanctuary being opened for commercial use. "Sanctuary means that the animals are protected from harvest," they said. This led to a lot of confusion. Who has the right to harvest? Where? When? and so on.
